TICKETING POLICY: All livestock exhibitors will be issued **one complimentary FIVE (5) day pass**. If livestock are required to be on grounds more than FIVE (5) days, an additional FIVE (5) day pass will be issued.

Livestock exhibitors may purchase no more than **THREE (3)** exhibitor passes at \$25 per pass. Passes will allow gate access and will be valid for any FIVE (5) days of the fair. Exhibitors must purchase livestock passes on the Official Entry form by 12 Noon, July 18, 2009.

OFF-ROADS VEHICLE POLICY

In the interest of creating a safer environment for everyone concerned, the STATE FAIR OF WEST VIRGINIA, will no longer permit the use of any OFF-ROAD VEHICLES (i.e. ATV's, golf carts, "gators", etc.) on either the main fairgrounds or in the public parking/camping areas.

EXHIBITORS' PET POLICY

Public Camping Lots 1, 2, and 3 and carnival. Pets **must be kept on a leash and** confined to the immediate campsite area. Owner must have appropriate papers showing proof of vaccination within the past 12 months for the following diseases: Dogs-Rabies, Distemper, Hepatitis, Leptospirosis, and Parvovirus. Cats-Rabies, Feline Panleukopenia, Feline Rhinotracheitis, and Calicivirus. Violation of this rule will result in expulsion from the fairgrounds with no refunds given. **PETS ARE NOT PERMITTED INSIDE LIVESTOCK BARN OR SHOW ARENAS OR ANY PUBLIC AREAS OF THE FACILITY.**
